- (i) There was an operational delay of 1 day in repayment of an instalment (Rs. 0.06 billion) to one of the lender (Bank) as on December 30, 2024, which was immediately remediated on December 31, 2024. Due to this, on January 06, 2025, India Ratings and Research Private Limited had downgraded the Issuer's long-term bank loans and short-term bank loans rating to 'IND-D'. However, on the same day, the rating was reassigned to 'IND AAA'/Stable and 'IND A1+' to Issuer's long term bank loans and short-term bank loans respectively. The Company had a current account in a bank with a balance of Rs. 4.72 billion on the due date of the payment. India Ratings and Research Private Limited has noted that the liquidity position of the Company, remained commensurate to the rating levels.
- (ii) The ratings have been reassigned in line with the agency's default recognition criteria and post-default curing period policy as the reasons for the delay in debt servicing has been addressed and the Company had resources in the form of bank balance of Rs. 4.72 billion on December 30, 2024 (EOD) which was significantly in excess of the amount required to fulfil the debt obligations. Also, the Company has taken measures to ensure non-recurrence of such instances.
- (iii) The Company had a technical delay of 1 day in payment of interest to one of the lender (Bank) of the Company in the FY 2024, which was immediately remediated.
